

In case there is any change of date / time in the opening of tenders, same will be notified in the News paper. Governor of Jammu & Kashmir Union Territory are invited from the original manufactures / authorized distributors / dealers for supply, installation and commissioning of **EPABX System** in interview room at District Jail Kishtwar **alongwith three years Annual Maintenance Contract (AMC) as specified in the annexure 'A' to this NIT.**

02. The tender documents can be had from the office of the Superintendent District Jail Kishtwar on all working days till 25.02.2020 upto 1600 hours against cash payment of Rs.100/- (Rupees one hundred) only which shall be non-refundable.

03. The last date receipt of sealed tender's has been fixed as 29.02.2020 upto 1600 hours in the office of Superintendent District Jail Kishtwar. The sealed tender boxes containing tenders shall be opened on 02.03.2020 by the Committee at 1130 hours in the office chambers of the Superintendent District Jail Kishtwar. In case there is any change of date/ time in the opening of tenders same will be notified in the News paper. The tenders or their authorized representatives can remain present on the date of opening of tenderers if they desire. The department shall not be responsible for any late postal delivery at any cost.

04. In case 29.02.2020 is declared a Government holiday, the sealed tenders shall be received on next working day up to 1600 hours.

05. The intending tenderers will have to enclose fresh requisite earnest money in the shape of CDR/FDR from any nationalized / scheduled bank pledged to the Superintendent District Jail Kishtwar along with the tenders separately failing which the tenders shall be out-rightly rejected even if the quoted rates are lowest.

06. The rates tendered for should be quoted both in words and in figures and should be inclusive of all taxes including GST if any.

07. Tenders should be filled in clearly and with same ink rates written both in figures and words. No additions / alterations / over-writing etc. of any sort be made in tender correction if any done in tender should be made clearly and properly authenticated by the tenderers under their seal and signature.

08. The electronic items shall be delivered / supplied / installed at F.O.R Superintendent District Jail Kishtwar.

09. No conditional tender will be accepted / entertained.

10. Where-ever a tenderer/s claims to be authorized representatives /agent / dealer / sole proprietor /distributor of a company, he shall enclose a written authority of the company declaring him as such.

11. The successful tenderer/s shall have to make an agreement with the Department soon after the allotment of contract is made in their favour. The CDR/FDR of un-successful tenderer/s shall be released only after the contracts are finalized by the department.

12. The amount of Annual Maintenance Contact shall be paid quarterly basis.

13. Payment shall be made by the Department against each consignment delivered, inspected, accepted and properly surveyed and material brought on stock in the concerned stock register of the Department. No advance payment shall be made.

14. As soon as the acceptance of the tender is communicated to the successful tenderer/s, the contract shall be final and binding on him. The earnest money in the shape of CDR / FDR of the tenderer/s who back out or withdraws tenders or fail to abide by it after acceptance shall be forfeited besides other remedies that may be available to the Government of J&K state under the prevalent laws in force in the state of J&K shall be applied.

15. If the successful tenderer/s fails to supply the goods of the prescribed specifications or fails to deliver / install the goods within the 15 days time period which shall be specifically mentioned in the supply order, the department shall be at liberty to arrange supplies from other alternate sources at the risk and cost of tenderer/s.

16. All legal proceedings arising out of any dispute between the parties shall have to be instituted in the Courts J&K UT Jammu or Kashmir and not elsewhere. In case of any dispute, the decision of the Superintendent District Jail Kishtwar shall be final and binding upon both parties.

17. The successful tenderer/s shall arrange supplies within the period mentioned in the supply order. The period of delivery and validity can however be extended if mutually agreed to.

18. The contract /supply order can be cancelled any time if the supplies are not made according to satisfaction of the Department.

19. The items supplied should be strictly in accordance with specifications mentioned in the supply order.
