Sealed Tenders affixed with revenue stamps for an amount of Rs. 05/- on behalf of Lt. Governor Union Territory of Jammu & Kashmir are invited from the original Manufactures / Authorized distributors / dealers registered with the Sales Tax Department/ Drugs Departments for **SUPPLY OF MEDICINES (GENERIC DRUGS) AND SURGICAL ITEMS TO DISTRICT JAIL KISHTWAR.** as per the original NIT. The intending tenderer's shall have to attach earnest money in the shape of CDR/FDR to the tune of Rs. 15,000/- (Rupees fifteen thousand only) from any Nationalized/Scheduled Bank to be pledged to the Superintendent District Jail Kishtwar.

The tender documents can be had against cash payment of Rs.200/- (Rupees two hundred only) non-refundable on all working days from the office of the Superintendent District Jail Kishtwar till **25.02.2020.**

The last dates of receipt of sealed tenders have been fixed as **29.02.2020** in the office of superintendent District Jail Kishtwar. In case **29.02.2020** is declared a Government holiday the sealed tenders shall be received next working day upto 1600 hours. The sealed tender box containing tenders shall be opened on **02.03.2020** by the Committee at 1130 hours in the office chambers of the Superintendent District Jail Kishtwar. In case there is any change of date / time in the opening of tenders, same will be notified in the News paper. The tenderers or their authorized representatives can remain present on the date of opening of tenders if they desire so.

2. The tender documents can be had from the office of the Superintendent District Jail Kishotvar, on all working days up to 25.02.2020 upto 1400 hours against cash payment of Rs. 200/- (Rupees two hundred) only which shall be non-refundable.
3. The last date of receipt of sealed tender/s has been fixed as 29.02.2020 upto 1600 hours in the office of Superintendent District Jail Kishotvar. The sealed tender box/es containing tenders shall be opened on 02.03.2020 by the Committee at 1130 hours in the office chambers of Superintendent District Jail Kishotvar. In case there is any change of date / time in the opening of tenders same will be notified in the News paper. The tenders or their authorized representatives can remain present on the date of opening of tenderer(s) if they desire. The department shall not be responsible for any late postal delivery at any cost.
4. In case 29.02.2020 is declared a Government holiday, the sealed tenders shall be received till next working day up to 1600 hours
5. The intending tenderer/s will have to enclose fresh requisite earnest money in the shape of CDR/FDR from any Nationalized / scheduled bank pledged to the Superintendent, District Jail Kishotvar along with the tender/s separately failing which the tender/s shall be out-rightly rejected even if the quoted rates are lowest.
6. The tenderer / bidders are required to offer rates by allowing discount on standard drugs/ Generic drugs and Surgical items . The lowest bidder shall be considered the one offering highest discount. The discount offered should be quoted both in words and in figures and should be inclusive of all taxes if any.
7. Tenders should be filled-in clearly and with same ink with rates written both in figures and words. No additions / alterations/ overwriting etc of any sort be made in tender. Correction if any done in tender should be made clearly and properly authenticated by the tenderer/s under his seal and signature.
8. The item shall be delivered / supplied at F.O.R. District Jail
9. No conditional tender will be accepted / entertained.
