The intending tenderer/s shall have to attach earnest money in the shape of CDR/FDR from any Nationalized/Scheduled Bank to be pledged to the Superintendent District Jail Baramulla, for an amount to the extent shown against each below:-

The last date of receipt of sealed tender/s is fixed as **2nd of January 2019 upto 1500 hours** in the office of Superintendent District Jail Baramulla. In case 2nd January-2019 is declared a Government holiday the sealed tender/s shall be received next working day upto **1500 hours**. The sealed tender box/ containing tenders shall be opened on **5th of January 2019** by the Departmental District Level Purchase Committee at **1100 hours** in the office chambers of Superintendent District Jail Baramulla. The tenderers or their authorized representatives can remain present on the date of opening of tenders if they desire. The terms and conditions shall remain same.

The supply order shall be placed in favour of approved tenderer by the Superintendent District jail Baramulla, indicating in the supply order the quantity of supplies to be made (based on their optimum requirement keeping in view the population of Jails) and the period within which supplies shall be made.
