

Terms & Conditions

1. The approved firm will have to enter an agreement with this office/ Department for supply of the items as per terms & conditions for the current financial year or till such time the new contract comes into force.
2. The medicines have to be provided as per the supply order immediately on the prescription of Medical Officer of District Jail Kathua or a Specialist Doctor of a Government Hospital.
3. The payment will be made after receiving the supply as per quality and quantity of medicine and no advance payment will be made.
4. The supplier should have to deposit Rs. 20,000/- Earnest money through CDR in favour of the Superintendent District Jail Kathua.
5. The Firm / supplier should be registered with GST.
6. The Selection Criteria for the bid shall be highest percentage discount offered on the medicines under the three above mentioned categories.
7. The approved supplier will be bound to supply the medicines to this Institution and in case of refusal for supply of medicines, his Earnest money will be forfeited.
